**a) Investment in Clarks Future Footwear Limited ("CFFL")**

Future Ventures India Limited ("FVIL") has made an additional investment in CFFL by subscribing to 20,00,000 equity shares of Rs. 10/- each.

As informed earlier, CFFL is a joint venture company, between C & J Clark International Limited, U.K ("Clark") and FVIL each holding 50% of the paid-up share capital of CFFL.

CFFL is into the business of marketing and distribution of footwear of all types and ranges under the International brand name of "Clarks" in India.
