 The above results were reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on November 14, 2011. Above results for the quarter / half year ended September 30, 2011 have been subjected to a Limited Review by the statutory auditors.
- 3 Additional investments made during the quarter includes additional stake of 30.82% acquired in Amar Chitra Katha Pvt. Ltd. and as a result of this it became subsidiary from being an associate.
- 4 The Company is primarily engaged in the business of investing/financing and building consumer product Businesses/Brands. Further, the Company does not have any operations outside India. As such, there are no separate reportable segments as per AS 17 "Segmental Reporting" on standalone basis.
- 5 During the half year ended September 30, 2011, the Company made an Initial Public Offer ("IPO") of 750,000,000 Shares of Rs. 10 each at a price of Rs. 10 each raising Rs. 7,500,000,000 during the month of April 2011. The shares of the Company were listed on National Stock Exchange of India Limited ("NSE") and Bombay Stock Exchange Limited ("BSE") on May 10, 2011.
- 6 Item 8 Exceptional Item represents IPO expenses incurred by the Company. The IPO Committee, in their meeting held on May 05, 2011 has allotted 750,000,000 Shares at par value of Rs. 10 per equity share. Consequently, there is no amount to be credited to the Securities Premium Account and the IPO expenses incurred have to be charged to Profit and Loss Account as and when they are incurred. Accordingly, expenses aggregating to Rs. 3,231.13 lakhs incurred during the half year ended September 30, 2011 have been absorbed in the Profit & Loss Account. Similar expenditure incurred during the half year ended September 30, 2010 was not expensed in that period as it was proposed to be adjusted against the Securities Premium Account on completion of IPO and was carried under Miscellaneous Expenditure (to the extent not written off or adjusted) as at September 30, 2010 and was subsequently written off.
