

Annexure

Investment in Holii Accessories Private Limited ("Holii")

Future Ventures India Limited ("FVIL") has subscribed to and has been allotted 1,50,000 equity shares of Holii.

Holii is a joint venture company between Hidesign India Private Limited ("Hidesign") and FVIL, each holding 50% of its paid-up equity share capital. Consequent to the rights offer made by Holii, equal shares have been allotted to Hidesign.

Holii is in the business of designing and distributing fashion accessories, such as luxury handbags, wallets and other products for women, under the brand name "Holli". The aggregate infusion of ₹ 3.00 Crore by the joint venture partners subscribing to the equity shares of Holii, will be deployed to meet its working capital and other business requirements.

The total revenue for Holii during the financial year ended 31st March, 2012 was ₹ 570.60 Lakh as against ₹ 393.41 Lakh for the year prior to that.

In the regular course of its business operations, Holii enters into business transactions with the Promoters and/or Promoter Group companies of FVIL.
